 - Adult in charge of show should be at the entire show and know the rules. That is being addressed.
 - Judge to not make the show a clinic.
 - They want large bulletin boards in the barns for more information. There is no place to hang stuff like that, so maybe we just put more slideshow info in the tv's.
 - They want pen assignments by skill-athon.
 - They had a record number of returning JF Board members.
- c) Livestock Committee/Von Cremeans
 - Jeff Wippel sent over a few notes on approved dates.
 - Online registration will be April 15th- May 15th.
 - Late fee will be \$25 from June 1st-18th.

- No late fee for showmanship.
- No entries after the first Saturday of the fair which is June 18th this year.

d) All Committees

- Craft Show/ Scott Pritchard- Vendors will be donating an item they are selling
 to be put in a raffle the money is to go back to the fair King and Queen for
 expenses. Will need a motion in new business.
- Camping/Von Cremeans- camper pull out will be on Saturday from 6am12pm or Sunday 8am-8pm. Move in will still be Thursday from 4pm-8pm
 with the extra night fee, Friday noom-8pm and Saturday 7am-8pm. Someone
 will be here at those times to show them where to pull their campers. When
 they arrive, they will call the office and the office will radio someone to direct
 them to their correct spot. Any violations will forfeit camping and will go
 back on a waiting list.

 Sunday morning. Block off a section of parking lot for move in. Horse barn
 closed on show days. There will be some show bill changes. And no animals
 to walk between the barns and arena during showtimes.
- Goats & Sheep/ Craig Weiler by Von Cremeans- 9am for daily cleaning and final clean-out will be from the time the animal is loaded till noon on Sunday. Kids and family will be allowed in the barn during load out.
- Swine/Jay Jude- 9am for daily cleaning and final clean-out will be by 5pm Sunday. No one will be allowed in the barn for load out.
- Poultry/Frank Reisinger- 9am for daily pen cleaning and final clean-out by noon on Sunday.
- Pen assignments for all species will be by club, therefore the club will assign pens and be responsible to make sure all pens are clean
