## VII. Committee Reports

- a) Junior Fair Board/ Joy Sharp
  - Eva Merritt Pickaway Co. Junior fair board President reported they had their first meeting last night that went well. They did a lot of activities and games for the new members. She stated that they discussed Steer weigh ins and they had a record breaking number of volunteers for weigh ins. She feels all junior fair board members are eager to get more involved this upcoming year.
  - The board asked Eva how many new members there are on Junior Fair board, she stated there are 37 members total, 23 returning and 14 new members.
  - Samantha Mayhugh, 2023 Pickaway Co. Fair Oueen, (accompanied by Abigail Baker, 2023 Pickaway Co. Fair Princess, Mitchell Ruff, 2023 Pickaway Co. Fair King, and Eva Merritt, 2023 Pickaway Co. Fair 1<sup>st</sup> attendant) brought forth their idea to the board regarding the event that they hosted last year. Heritage Hoedown. Samantha stated they had 60 in attendance in last year, all of which were Ohio Fair Royalty, (they did line dancing, cornhole, and horseshoes) she stated as she was traveling to other fairs this year the royalties were still talking about it and how much fun they had. Samantha, Abigail, Eva, and Mitchell would like the board to approve them hosting this event again this year on January 20<sup>th</sup>. Christy has already confirmed the date is available.
