



2018 Pickaway County Fair Week Camping Lottery Process

For the safety and fairness to all Pickaway County Fair campers, directors and staff, **Pickaway County Agricultural Society is implementing a new camping lottery system for 2018 fair week camping** for current campers wishing to swap camp spots and new campers. Anyone who is not respectful of the system and process, and/or shows up in person to the fair board office at any time wishing for exceptions will be disqualified from the lottery process and may forfeit their current camping spot, if applicable.

The system will work as follows:

- **CURRENT CAMPERS** who have camped at the Pickaway County Fair that are wishing to swap camp spots AND have already completed the 2018 camping application process and paid in full **MUST** fill out the enclosed/attached lottery application, and mail or hand deliver to: Pickaway County Agricultural Society, 415 Lancaster Pike, Circleville, OH 43113 by **close of business (4:00pm) Friday, March 23, 2018** (*mailed applications must be received by this date to be included in lottery*). No exceptions.
 - All camp spot swaps requested by current campers will be entered into an automated online system that randomly selects prioritization of camp spot requests. The process will take place after normal business office hours (after 4:00pm) on Friday, March 23, 2018 and will be entered and supervised by Camping Committee members. Campers may not remain on site during process. No exceptions.
 - Campers will be notified by a phone call by a Camping Committee member on the evening of Friday, March 23, 2018 before 9:00pm on the status of their request.
 - If not reached in person by phone one courtesy voice mail will be left. Campers must confirm/accept no later than noon on Monday, March 26, 2018 by calling 740.474.2085. A message may be left – leave name and simply state “I accept spot #...” or “I decline spot #...”. If no response is received from camper by noon Monday, March 26, 2018 request is null and void, and therefore forfeited. Current camp spot assignment will remain as is. No other requests will be accepted or considered. No exceptions.
- **NEW CAMPERS** who have not previously camped at the Pickaway County Fair before **MUST** fill out the enclosed/attached lottery application, and mail or hand deliver to: Pickaway County Agricultural Society, 415 Lancaster Pike, Circleville, OH 43113 by **close of business (4:00pm) Friday, March 30, 2018** (*mailed applications must be received by this date to be included in lottery*). No exceptions.
 - All new camp spot requests by new campers will be entered into an automated online system that randomly selects prioritization of camp spot requests of available camp spots. The process will take place after normal business office hours (after 4:00pm) on Friday, March 30, 2018 and will be entered and supervised by Camping Committee members. Campers may not remain on site during process. No exceptions.
 - Campers will be notified by a phone call by a Camping Committee member on the evening of Friday, March 30 before 9:00pm on the status of their request.
 - If not reached in person by phone one courtesy voice mail will be left. Campers must confirm/accept no later than noon on Monday, April 3, 2018 by calling 740.474.2085. A message may be left – leave name and simply state “I accept spot #...” or “I decline spot #...”. If no response is received from camper by noon Wednesday, March 28, 2018 request is null and void, and therefore forfeited. No other requests will be accepted or considered. No exceptions.
 - Once camper accepts a completed camping contract, information sheet and payment in-full for camping and exhibitor ticket or PCAS membership must be received at the Fair Board Office no later than 3:00pm Friday, April 6, 2018. If completed camping contract, information sheet, and payment is not received by 3:00pm Friday, April 6, 2018 request is null and void, and therefore forfeited. No other requests will be accepted or considered. No exceptions.
