- Junior Fair Board- In attendance from Junior fair board were: Olivia Snyder and Kaitlyn Ball.
- Junior Fair board reported they had their work day the previous Saturday where they weeded and planted flowers.
- JFB members reported that at their last meeting they went over fair rules.
- Junior fair royalty reports that they will have sandwiches and desserts for the luncheon for visiting royalty. The princess contest is the same time as king and queen and applications are out. They have also found 2 of their 3 judges.
- Joy Sharp reported that banners are in and ribbons are ordered as well as trophies and medals. Quality Assurance and Equistep are all complete. Dog and horse registrations are in. Dog workouts have been underway and they have 1 left. Horses also have 1 workout left. Skill-a-thon will be June 3rd from 930am-230pm and June 4th from 2pm-7pm.
- Livestock Sales Committee- Jeff Wippel reported that online entries close Thursday the 15th. Tag in numbers Market show- 149, 8 families for a total of 157, Purebred barrows- 19 for a max of 160 hogs for 2025. Goats-76, Lambs-44, Dair beef feeders-15. The next sale committee meeting is the 28th of May.
- Sponsorship/ Advertising Committee- Christy Pence reported that we have 40 committed sponsors and a total of \$49,000 paid in sponsorships. We also still have 2 day sponsorships available. Christy Pence reported that they had several promotional items to pass out at tourism Ohio where thousands of people would be attending. She also reported that we would have a fundraiser day with City BBQ where 20% of all sales will go to the Ag society.
