- Junior Fair board reported they had their work day where they weeded and planted flowers. They are having another work day next week to get ribbons and awards ready. They got a grant after last fair for \$2000, they spent \$500 on community cupboards and \$1500 on Ronald McDonald house which they delivered at their last work day.
- Royalty reported that they have done 2 parades, deer creek dam days and commercial point homecoming. They reported on the upcoming king/queen contest and stated they are prepared for the royalty luncheon.
- Joy Sharp reported that they have been working to get everything ready and support all the committees. She has been working on gates committee on passing out wristbands and backtags. They will be moving stuff in for fair next week. Sale committee is working on entries and they have had several questions on breeds. Skill-a-thon is this week and there will be no other skill-a-thon after Wednesday at 7pm.
