Last Wednesday royalty visited the Logan county fair for their livestock scramble which they said was very entertaining. They have felt very welcomed at every fair they attended.

c. Disciplinary actions from fair

- Joy stated that any disciplinary actions that need to be taken from fair need to be recorded as part of the meeting minutes and warning letters need to be issued.
- Courtney Melton was carded (level 1 discipline) for rabbits, then during the sale the market rabbits were not loaded on to the packer truck and were also not in the

barn. Rabbits were required to be taken to the packer by June 28th. Courtney will not be eligible to show rabbits at state fair 2025, she also will not be eligible to show rabbits at county and state in 2026.

- Jen Hendershot-Capsel reported that Audra Anderson of the Westfall FFA and Ethan and Emma Black of the Wild wild west 4-H club will be receiving a charge for not cleaning their pens.
