  - Joy states they are currently pushing for everyone to get the Quality Assurance completed. Currently they are at about 40%. Advisors have requested that next year there be more in person Quality Assurance.
  - They are watching ODA teaches, 901-19 rules will be up for public on April 11<sup>th</sup> but will still need to be voted on.

- d. Fair book Committee- Several received emails from Von on Friday for fair book reviews and he only got 1 response. Fair book is going to be published Wednesday and we need reviews from committee chair persons.

- a. OKI Estimate for Fair/ Von Cremeans

  - Randy needs approval for the same amount as last year to purchase the Friend of the Fair Plaque. Christy Pence moves to approve. Ryan Sark seconded the motion. All in favor, motion carried.

- d. Building rental advertising/ Christy Pence
  - Christy would like to place a full page ad in the Pickaway County Magazine to promote the facilities. The magazine only goes out once a year. Cost of the full page ad is \$1,250.00. The magazine goes out to 10,000 households Donnie Smith moves to approve. Jennifer Hendershot-Capsel seconded the motion. All in favor, motion carried. Christy Pence abstained from the vote.
- e. Booth and Horse arena/ Randy Smith
  - At the cattle show little kids were jumping off the judges booth. Randy feels
    this is safety concern and would like to get gates put up around it. We will
    revisit the topic at a later date.
- f. Flooring in the cattle barn/ Von Cremeans
  - The sale company requested we get different flooring in the cattle barn. Von had Foster put in the asphalt grindings floor since the Horse sale renters have been asking for 3 years and they are loyal renters. The bill came and it was \$18,000. Von spoke with Foster who agreed to cut the bill in half. Von would like the board to decide if it's being paid for by PCAS or Gun-a-palooza. The board agreed on Gun-a-palooza.

  - We are preparing to submit our application for the Grant. We are applying for \$45,000 for new LED Sign. \$55,000 to finish electric and get permanent camping permit. They would also like to request if possible an extra \$16,000 for lights in the parking lot.
